In recent years, research has increasingly emphasized molecular oncology and genetics, areas which bridge advancing knowledge from the laboratory with new clinical approaches.

The research facilities have been structured to fulfill the needs of the multi-disciplinary research programs at Fox Chase Cancer Center.
